## Privacy Notice for Pupils and Parents

---

Our school needs to use data on pupils in order to be able to keep you safe and deliver the best education possible. Only essential data is held, and we always follow the law when we collect use, store and share your data.

You have a legal right to be informed about how our school uses any personal information that we hold about you. This privacy notice explains how we collect, store and use personal data about you.

We have updated this privacy notice with information about how we may share your data for 'test and trace' services to support public health.

We, Rode and Norton St Philip School Federation, are the 'data controller' for the purposes of data protection law.

Our Data Protection Officer (DPO) is Amy Brittan (see 'Contact us' below).

### The personal data we hold on pupils

We hold some personal information about you to make sure we can help you learn and look after you at school.

For the same reasons, we get information about you from some other places too – like other schools, the local council and the government.

This information includes but is not limited to:

- Your contact details
- Assessments of your work
- Your attendance records
- Your characteristics, like your ethnic background or any special educational needs
- Any medical conditions you have
- Details of any behaviour issues or exclusions
- Photographs

### The personal data we hold on parents

We hold some personal information about your parents to make sure we can help you learn and look after you at school.

- Contact details
- We may also hold some information about parents if your child has a safeguarding folder

### Why we use this data

We use this data to help run the school, including to:

- Get in touch your parents when we need to
- Check how pupils are doing and work out whether pupils or teachers need any extra help
- Track how well the school as a whole is performing
- Look after pupil wellbeing

### Our legal basis for using this data

- We need to comply with the law (*Article 6(1)(c) of GDPR*)

- We need to use it to carry out a task in the public interest (in order to provide you with an education) (*Article 6(1)(e) of GDPR*)

Sometimes, we may also use your personal information where:

- Pupils, or parents/carers have given us permission to use it in a certain way (*Article 6(1)(a) of GDPR*)
- We need to protect your interests (or someone else's interest) e.g. in a life or death situation (*Article 6(1)(d) of GDPR*)

We may also collect and use information about pupil health. This is a special category of personal information, and we will only collect and use it when it is necessary for public health, e.g. protecting against serious threats to health. The legal basis here is *Article 9(2)(i) of GDPR*.

Public Health England also has special permission from the Secretary of State for Health and Social Care to use personally identifiable information without your permission where this is in the public interest. This is known as 'Section 251' approval and includes the use of the information collected by NHS Test and Trace to help protect the public from coronavirus. The part of the law that applies here is Section 251 of the National Health Service Act 2006 and the associated Health Service (Control of Patient Information) Regulations 2002.

Where we have got permission to use pupil data, parents/carers may withdraw this at any time. We will make this clear when we ask for permission and explain how to go about withdrawing consent.

Some of the reasons listed above for collecting and using your information overlap, and there may be several grounds which mean we can use your data.

### Collecting this information

While in most cases parents/carers, must provide the personal information we need to collect, there are some occasions when parents/carers can choose whether or not to provide the data. We will always tell you if it's optional. If you must provide the data, we will explain what might happen if you don't.

### Data sharing

We do not share personal information about pupils or parents/carers with anyone outside the school without permission from your parents/carers, unless the law and our policies allow us to do so. Where it is legally required, or necessary for another reason allowed under data protection law, we may share personal information about pupils or parents/carers with:

Who we share with	Why we share
Our local authority	To meet our legal duties to share certain information with it, such as concerns about pupils' safety and exclusions
The Department for Education	We have to do this by law. This data sharing underpins school funding, educational policy and funding
Your family and representatives	To ensure that they know how you are doing and to protect your welfare

Police forces, courts, tribunals and security services	As we are required to by law
Educators and examining bodies	To ensure that you are entered for exams and your results are recorded
Health and social welfare organisations	Such as the school nurse and the Education Welfare Officer to help look after your health and wellbeing
Our payment service providers - ParentPay	So that you can pay for meals, trips resources and activities.
Providers of electronic learning resources	To allow you to use their resources in class and at home
School Cloud: Parents Evening	To allow you and your parents to book and participate in a virtual Parents' Evening appointment (minimum data is uploaded and no recordings are made)

### How we store this data

We will keep personal information about pupils while they are a pupil at our school. We may also keep it after they have left the school, where we are required to by law.

Our record retention schedule/records management policy is based on the [Information and Records Management Society's toolkit for schools](#) and sets out how long we keep information about pupils.

### National Pupil Database

We are required to provide information about pupils to the Department for Education (a government department) as part of data collections such as the school census.

Some of this information is then stored in the [National Pupil Database](#), which is managed by the Department for Education and provides evidence on how schools are performing. This, in turn, supports research.

It is held in electronic format for statistical purposes. This information is securely collected from a range of sources including schools, local authorities and awarding bodies.

### Sharing by the Department for Education (DfE)

Organisations fighting or identifying crime may use their legal powers to contact the DfE to request access to individual level information relevant to detecting that crime. Whilst numbers fluctuate slightly over time, the DfE typically supplies data on around 600 pupils per year to the Home Office and roughly 1 per year to the Police.

### Transferring data internationally

Where we share data with an organisation that is based outside the European Economic Area, we will protect your data by following data protection law and current best practice guidance as indicated by the Information Commissioner's Office.

## Your rights

### How to access personal information we hold about pupils or parents/carers

Parents/carers can find out if we hold any personal information about pupils or themselves, and how we use it, by making a 'subject access request', as long as we judge that you can properly understand your rights and what they mean.

### If we do hold information about you, we will:

- Give you a description of it
- Tell you why we are holding and using it, and how long we will keep it for
- Explain where we got it from, if not from you or your parents
- Tell you who it has been, or will be, shared with
- Let you know if we are using your data to make any automated decisions (decisions being taken by a computer or machine, rather than by a person)
- Give you a copy of the information

You may also ask us to send your personal information to another organisation electronically in certain circumstances.

If you want to make a request please contact our data protection officer.

### How to find out what personal information the DfE hold about pupils

Under the terms of the Data Protection Act 2018, you are entitled to ask the Department:

- if they are processing pupil personal data
- for a description of the data they hold about pupils

- the reasons they're holding it and any recipient it may be disclosed to
- for a copy of pupil personal data and any details of its source

### Your other rights over your and pupil data

You have other rights over how your personal data is used and kept safe, including the right to:

- Say that you don't want it to be used if this would cause, or is causing, harm or distress
- Stop it being used to send you marketing materials
- Say that you don't want it used to make automated decisions (decisions made by a computer or machine, rather than by a person)
- Have it corrected, deleted or destroyed if it is wrong, or restrict our use of it
- Claim compensation if the data protection rules are broken and this harms you in some way

### Complaints

We take any complaints about how we collect and use your personal data very seriously, so please let us know if you think we've done something wrong.
